

Basic Income Advocates Across Canada Applaud Historic Progress in Newfoundland and Labrador

November 14, 2023 - Last week, Newfoundland and Labrador took another small step towards the implementation of a guaranteed livable basic income - and made it clear that more steps are to come.

As part of the province's <u>newly-announced</u> Poverty Reduction Plan, Newfoundland and Labrador is implementing a Basic Income program for seniors aged 60-64 who are attached to the provincial income and community support programs. The Basic Income will bring their incomes in line with the benefit level they will receive once they turn 65 and move to federal seniors' benefits.

This is the second targeted basic income program implemented in Newfoundland and Labrador - last year, a similar program was introduced for young people in residential services. An all-party committee of the Newfoundland and Labrador House of Assembly is also in the final stages of an in-depth study of basic income, with a report and recommendations expected soon.

Basic income advocates across the country were also encouraged by NL Premier Andrew Furey's remarks at the launch of the Poverty Reduction Plan, during which he expressed strong support for a broader basic income program, highlighting the data showing the effectiveness of basic income and connecting many of the ongoing reforms happening in the province's social support systems to this goal.

With basic income endorsed by the PEI legislature and under study both in Newfoundland and Labrador and in the Canadian Senate, advocates from Basic Income NL, Basic Income Canada Network, and Coalition Canada Basic Income - revenu de base, are jointly calling on decision makers to move quickly to make this transformational policy a reality.
